

## 歐盟禁止強迫勞動產品規章(EU FLPBR)說明會

### 一、會議緣由

歐盟禁止強迫勞動產品規章(EU FLPBR)於 2024 年 12 月 13 日生效，並將自 2027 年 12 月 14 日起實施。該規章旨在透過禁止以強迫勞動製造之產品在歐盟市場上市、流通或自歐盟境內出口，以打擊強迫勞動，其適用範疇廣泛，涵蓋所有產品、供應鏈中各環節，以及所有位於歐盟境內的生產者、輸歐及自歐出口的業者。未來將直接影響我國輸歐業者，也會間接衝擊位處歐盟供應鏈的臺灣企業。

為協助我國業者掌握歐盟法規要求與最新執法趨勢，使企業得以及早因應符合規範並落實法遵，本次說明會特邀歐盟 Van Bael & Bellis 法律事務所說明歐盟禁止強迫勞動產品規章之要求及確保業者合規之策略，希望協助業者提前因應國際法規變化，提升競爭力與供應鏈韌性。

The EU's Forced Labour Products Ban Regulation (FLPBR) entered into force on 13 December 2024, one day after being published in the EU Official Journal, and will become applicable after 36 months. The Regulation aims to contribute to the fight against forced labour by banning goods made with such labour from being made available in the EU market or from being exported from the EU. The scope of the FLPBR is broad as it covers all products, every step in the supply chain, as well as every producer in the EU, importer into the EU and exporter from the EU. The Regulation will therefore directly affect Taiwanese companies that import any products into the EU, and also indirectly affect any Taiwanese enterprises in an EU supply chain.

To help Taiwanese businesses better understand the regulatory requirements and latest enforcement trends, and to support early preparation for compliance, this webinar will feature experts from the EU-based law firm Van Bael & Bellis, which will provide an overview of the FLPBR and outline strategies for ensuring corporate compliance. The webinar aims to equip companies with the knowledge to proactively respond to evolving international regulatory developments and enhance their competitiveness and supply chain resilience.
